Alcohol Sales for Package Sales

Shamshuddin Virani, managing agent of Country Boys LLC located at 2476 Cannon Bridge Road, submitted an alcohol license application and meets the following requirements pursuant to Habersham County Code of Ordinances Chapter 6 Section 6-5, Alcoholic Beverages:

- 1. Is over the age of 21;
- 2. Is a citizen of the United States;
- 3. Has no previous violations as listed in Section 6-3(b)3;
- 4. Is the owner of the property, or as a lessee has furnished a copy of the lease;
- 5. Shall be active in the operation of the outlet;
- 6. Property is in a land use district which allows the business or use;
- 7. Is not within 100 yards of any property line of a church or educational facility;
- 8. Has complied with all ordinance requirements pertaining to application for an alcohol license; and
- 9. Owes no delinquent taxes and/or assessments to Habersham County.

The applicant, having filed a complete application with all required supporting documents and having paid the required application and license fees, requests a license for sales of malted beverages and wine package sales at the property.

The Planning and Development Department has reviewed all submitted documents and finds the applicant in full compliance with the County's Alcoholic Beverage Code. Therefore, we recommend approval of this application.
