

RESOLUTION OF THE BOARD OF COMMISSIONERS OF HABERSHAM COUNTY, GEORGIA AUTHORIZING AND FIXING COMPENSATION FOR THE ATTORNEY APPOINTED PURSUANT TO O.C.G.A. SECTION 15-9-13(a) TO EXERCISE THE JURISDICTION OF THE HABERSHAM COUNTY PROBATE COURT DUE TO THE RECUSAL OF PAMELA WOOLEY, THE DULY ELECTED JUDGE OF THE PROBATE COURT OF HABERSHAM COUNTY, AND FOR OTHER PURPOSES.

WHEREAS, Habersham County, Georgia (“County”) is a political subdivision of the State of Georgia; and

WHEREAS, the Honorable Pamela Wooley, Judge of the Probate Court of Habersham County, Georgia (“Judge”), has recused herself in the matter of **In re: Carol O’Dell Lovell, File Number 811-055**, due to a conflict of interest;

WHEREAS, the Judge, pursuant to O.C.G.A. Section 15-9-13(a), is required to appoint an attorney to serve in her place in the above styled matter upon her recusal; and

WHEREAS, the Habersham County Board of Commissioners is required by O.C.G.A. Section 15-9-13(c) to adequately compensate the appointed attorney out of County funds;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Habersham County as follows:

The Habersham County Board of Commissioners hereby authorizes a per diem compensation of \$500.00 for the appointed attorney appointed by the Probate Court of Habersham County to serve as judge in the matter of **In re: Carol O’Dell Lovell, File Number 811-055**, effective immediately and continuing until the matter is resolved. The per diem compensation is applicable for each day that the appointee exercises the jurisdiction of the Probate Court of Habersham County in the above matter.

This resolution shall take effect immediately upon its adoption. All resolutions or parts thereof in conflict with this resolution are hereby repealed.
