MINUTES HABERSHAM COUNTY PLANNING COMMISSION Public Hearing Tuesday, May 7, 2024

The Habersham County Planning Commission held a public hearing on Tuesday, May 7, 2024, at the Habersham County Courthouse, located at 295 Llewellyn St. in Clarkesville, Georgia.

<u>CU-24-04:</u> Jonathan Smith is seeking a Conditional Use to allow construction of a mini storage facility with an additional parking area. The tract is located at 1443 E Mize Rd. and is further identified as Map 109 Parcel 013.

After the proposal was presented, the applicant was given a chance to speak.

Mr. Smith began to speak about the property and what his plans were. He said that he intends to add (10) 50×100 mini storage units. He plans to have an additional parking area in the back for people who need extra

space to park RV's, commercial vehicles, etc. Mr. Smith also mentioned that he wanted to enclose the facility with a fence and a gate that will be monitored by surveillance.

After Mr. Smith was finished speaking, those in favor or in opposition to the proposal were given a chance to speak as well.
