A regularly scheduled meeting of the Habersham County Board of Assessors was held on Monday, April 29, 2024, at 9:00 a.m. in the Conference Room on the 2nd floor located at 130 Jacob's Way, Clarkesville, in Habersham County, Georgia.

Present: Amy Sgro, Chairperson; Jimmy Dean, Vice-Chairperson; Bill Terry, Member; Joan Church, Chief Appraiser; Amy Garmon, Secretary

Absent: None

Chairperson Sgro called the meeting to order at 9:00 a.m.

Jimmy Dean delivered the invocation.

Approval of Agenda:

Motion made by Bill Terry to approve the April 29, 2024 agenda; seconded by Jimmy Dean; voted unanimously to approve motion.

Old Business:

Board Minutes: March 15, 2024

Motion made by Bill Terry to forego the reading and approve the minutes of March 15, 2024; seconded by Jimmy Dean; voted unanimously to approve motion.

By-Laws Update

Bill Terry wanted to be sure the public knew he brought this up to go to once a month and no one else did. Mr. Terry indicated it is hard for him to come on Monday's because he has staff meetings he has to miss with his church. The next meeting will be May 14th, 2024. Motion made by Bill Terry to change the 2nd & 4th Mondays to the 2nd & 4th Tuesdays of each month; seconded by Jimmy Dean; voted unanimously to approve motion.

Miscellaneous:

Vice Chairman Larson resigned from the Board this morning. Motion made by Bill Terry to appoint Jimmy Dean as vice-chair; seconded by Amy Sgro; voted unanimously to approve motion.

New Business:

Affidavit 2023-15

Motion by Jimmy Dean to approve the 2023 15 Affidavit; seconded by Bill Terry; voted unanimously to approve motion.

Homestead Exemption:

The attached listing of applicants for various homestead exemptions was submitted for review and approval by the Board for Tax Year 2024. Motion made by Bill Terry to approve the listing of homestead exemption applications for Tax Year 2024; seconded by Jimmy Dean; voted unanimously to approve motion.

The attached listing of applicants for various homestead exemptions was submitted for review and denial by the Board for Tax Year 2024. Motion made by Jimmy Dean to approve the denial listing of homestead exemption applications for Tax Year 2024; seconded by Bill Terry; voted unanimously to approve motion.

Miscellaneous:

Cone, Lester Wayne 047-001P

Ms. Garmon provided the Board with a Veteran Homestead Exemption filed by Mr. Lester Wayne Cone for Tax Year 2024. Mr. Cone is a 100% disabled veteran and has been since 2022. He is qualified for a refund for Tax Year 2023 in the amount of \$1,394.62. Motion made by Bill Terry to approve homestead for Mr. Lester Wayne Cone for Tax Year 2024 and to issue a refund for Tax Year 2023; seconded by Jimmy Dean; voted unanimously to approve motion.

Hatfield, Louise 131-008

Ms. Garmon provided the Board with a homestead exemption filed by Ms. Louise Hatfield. Ms. Hatfield was denied in Tax Year 2023 for no income submitted. However, she finally submitted the income but was over the limit. She came back into our office on April 18, 2024 and made application again. She provided her income tax return and does meet the income qualifications however, she was late in filing. Motion made by Jimmy Dean to deny for Tax Year 2024 the homestead exemption for Ms. Louise Hatfield; seconded by Bill Terry; voted unanimously to approve motion.

Moorehouse, David 029-032R

Ms. Garmon provided the Board with a Veteran Homestead Exemption filed by Mr. David Moorehouse for Tax Year 2024. Mr. Moorehouse was considered to be 100% disabled in August 2022; however, that amount changed to 90% in April 2023. As of January 2024, Mr. Moorehouse is considered 100% disabled. Motion made by Bill Terry to approve Mr. David Moorehouse for homestead exemption for Tax Year 2024; seconded by Jimmy Dean; voted unanimously to approve motion.

Conservation Use:

The Board reviewed the attached listing of applications for release for Conservation Use Valuation Assessment covenants expiring December 31, 2023 or breached, with and without penalties. Motion made by Bill Terry to

approve the releases for all covenants ending December 31, 2023; seconded by Jimmy Dean; voted unanimously to approve motion.

The Board reviewed the attached listing of applications for Conservation Use Valuation Assessment, over 10 acres, for Tax Year 2024. Motion made by Bill Terry to approve all new applications for CUVA for Tax Year 2024 for properties over 10 acres with recommended approval by appraisal staff; seconded by Jimmy Dean; voted unanimously to approve motion.

The Board reviewed the attached listing of applications for Conservation Use Valuation Assessment, under 10 acres, for Tax Year 2024. Motion made by Bill Terry to approve all new applications for CUVA for Tax Year 2024 for properties under 10 acres with recommended approval by appraisal staff; seconded by Jimmy Dean; voted unanimously to approve motion.

Exempt Application: The Hospital Authority of Hall County

Ms. Garmon provided the Board with an Exempt Application filed by The Hospital Authority of Hall County for 7 different properties. These 7 properties is what they purchased from the County that belonged to the Hospital Authority of Habersham County. Motion made by Jimmy Dean to approve exempt status for all 7 properties for Tax Year 2024; seconded by Bill Terry; voted unanimously to approve motion.

Redaction Request:

Camacho, Kimberly & Nasario

Ms. Garmon provided the Board with a redaction request for Mr. & Mrs. Camacho. Ms. Garmon indicated this redaction request would be for Tax Year 2025 since Mr. & Mrs. Camacho did not purchase it until March 2024. Motion made by Jimmy Dean to approve the redaction request for Kimberly & Nasario Camacho for Tax Year 2025; seconded by Bill Terry; voted unanimously to approve motion.

Cash, Dale

Ms. Garmon provided the Board with a redaction request for Mr. Dale Cash. Mr. Cash is a law enforcement officer and would like his information to be redacted. Motion made by Bill Terry to approve the redaction request for Mr. Dale Cash for Tax Year 2024; seconded by Jimmy Dean; voted unanimously to approve motion.

Brown, James Philip

Ms. Garmon provided the Board with a redaction request for Mr. James Philip Brown. Mr. Brown is a law enforcement officer and would like his information to be redacted. Motion made by Bill Terry to approve the redaction request for Mr. James Philip Brown for Tax Year 2024; seconded by Jimmy Dean; voted unanimously to approve motion.

Motion by Bill Terry to take a 5-minute recess; seconded by Jimmy Dean; voted unanimously to approve recess at 10:15 a.m.

Motion by Bill Terry to return to regular session; seconded by Jimmy Dean; voted unanimously to return to regular session at 10:20 a.m.

2024 Conservation Use Values

Ms. Church provided the Board with a listing of the new 2024 Conservation Values. She explained the state sets these values each year and can only go up or down 3% each year. Motion made by Bill Terry to approve the 2024 Conservation Use Values; seconded by Jimmy Dean; voted unanimously to approve motion.

2024 Forest Land Protection Act Values

Ms. Church provided the Board with a listing of the new 2024 Conservation Values. She explained the state sets these values each year and can only go up or down 3% each year. Motion made by Jimmy Dean to approve the 2024 Conservation Use Values; seconded by Bill Terry; voted unanimously to approve motion.

Status Update from Chief Appraiser

Ms. Church provided the Board with the status report of everything that has been happening since the last meeting. The following is a listing of items that was discussed:

- Sales Info: Been reviewing sales for Qualified sales in the county.
- Ms. Church & Ms. Garmon attended an intro session on Change Finder Connect Assessment. Then several days later, the appraisers & Ms. Church & Ms. Garmon had a more in depth training session on Change Finder.
- Ms. Church met with McCormick to discuss base rates. The McCormick's indicated the increase from \$110 per square foot to \$140 per square foot was inline with what they are seeing in other counties. After discussion, the Board requested McCormick to be in attendance at one of the May meetings.
- We hired a new employee that started on April 22, 2024. Her name is Danielle McMillan. She will be a field appraiser once she is able to attend classes and pass her appraiser exam.
- We also had a holiday since the last meeting. The office was closed on March 29 for Good Friday.
- Ms. Church informed the Board that Curt Shedd resigned a few weeks ago.

Miscellaneous:


