#### COMMISSION ACTION REQUESTED ON: 01/21/2025

**PURPOSE:** To seek approval from the Habersham County Board of Commissioners to approve the contract and service agreement with Southeastern Fire Consulting Company, LLC. SEFCCO will evaluate the fire service delivery and Fire Protection Classification in Habersham County, including the cities which have indicated by resolution a desire to participate in the study.

#### **BACKGROUND / HISTORY:**

- a. In July of 2024, Habersham County Administration and Emergency Services was approached about having a discussion with the municipalities regarding the consolidation of fire services throughout the county.
- b. The subject was initially introduced to the city officials, informally, at the Fall HC3 meeting.
- c. A meeting was conducted at Demorest City Hall on November 21<sup>st</sup>, 2024, to introduce the subject to all interested city officials and to indicate the commitment of the municipalities by resolution by the end of December 2024.

#### FACTS AND ISSUES:

- a. Baldwin, Clarkesville, Cornelia, Demorest and Tallulah Falls produced resolutions to participate in the study.
- b. The city officials have committed to providing the necessary information to Thad Dixon, the consultant, to conduct the analysis of the fire response system in the county.
- c. The contract specifies \$55,000.00 for the study.
- d. There is no post-study obligation on the part of the cities.
- e. The Fire Protection Classification (ISO) for unincorporated Habersham County was last evaluated in December of 2018 and published in July 2019. The current classification is 5/10. Most of the county is a Class 5, but a few small areas are a 10. Automatic Aid agreements with the city departments and surrounding counties assist in bringing some areas into the 5 Classification.

# **DESCRIPTION OF SERVICES and ACTIONS**

The SouthEastern Fire Consulting Company, LLC (here after referred to as SEFCCO) has prepared this Quote for Services for Habersham County, GA and all participating municipalities. This quote & contract has been prepared at the request of Jeff Adams, Fire Chief, Habersham County, GA.

SEFCCO will conduct an analysis of the fire operations of Habersham County, GA and each of the participating municipalities.

SEFCCO will conduct an analysis of the ISO/VERISK public protection classifications (PPC) of the Habersham County Fire District and each independent municipal fire rating as they currently stand.

SEFCCO will conduct an analysis of the relative classification for the Habersham County Fire protection district and of each participating municipality. SEFCCO will then do an analysis of the effect of merger between individual standing fire departments vs. a consolidated fire department.

SEFCCO will conduct an analysis on merger of property owned by individual municipalities into the Habersham County Fire Department.

SEFCCO will conduct an analysis of the merger of personnel by individual municipalities into the Habersham County Fire Department.

# **DESCRIPTION OF SERVICES and ACTIONS**

SEFCCO will conduct a budget analysis on Habersham County as it pertains to the merger of the individual municipal fire departments within Habersham County.

SEFCCO will conduct a thorough study of the Habersham County Fire Department which will include response times, barriers to response (natural and man-made), and a travel study in order to recommend fire station and fire company placement for maximum efficiency. As part of this section, we will look at the proximity of the current municipal fire stations to see if spacing modifications need to be made, as part of a consolidated agency.

The above item is part of the Deployment Analysis section of the Public Protection Classification. As part of this study, we will recommend improvements to the Deployment Analysis, which will improve response times and public safety for citizens and emergency responders.

Once this contract is effective, all participating agencies (outlined on page XX) will be requested to provide a variety of information including but not limited to: the last ISO/Verisk Survey, Itemized lists of vehicles and equipment, Real Property (such as fire stations), Personnel Listings including rank structure and salaries, Budget Information, Emergency and Non-Emergency Response Information, ETC...,.

SEFCCO will request for each agency to list any challenges that they face so that these situations can be addressed.

# **G.I.S.** Graphic Information Systems

SEFCCO will be looking at current mapping information for Habersham County and its municipalities. As part of this process, we will be creating new response mapping. We request access to the Habersham County GIS services during this study. This will save Habersham County additional charges as our contracted GIS service will charge for service and that amount will be outside of the contracted amount for this study.

# **Recommendation**

During this process, we recommend that a training session be held for public officials which explains the process of the ISO/Verisk Public Protection Classification. This is optional for our clients but it is a good way for all to see that the PPC Rating is a community effort and not just that of the fire department. We offer this training at no additional charge.

Examples of who would attend are... the Fire Department, Water Department, 911 Communications Center, GIS Department, Personnel from County & City Management & Financial, Chamber of Commerce and or any other local organization that the Habersham County Government deems necessary.

This process of bringing these parts of the government and community together, to share the ISO process, creates buy-in and gives everyone a sense of ownership.

# **Payment for Consultation Services**

SEFCCO has two payment methods for our services...

Our first and preferred method of payment is by Electronic Fund Transfer (EFT). If Habersham County selects this method of payment, we will provide an EFT Authorization Form with the detailed payment information.

The second method of payment is by official government check. If this method is selected, we request that checks are mailed to the address on the header of this contract by certified mail with return receipt. We have put this request on all items arriving by U.S. Mail due to delivery issues in our area.

The total contracted amount will be divided into 12 monthly installments, (see page-5). The first installment will be due upon signing of this contract, and the remaining 11 installments will be due on the signing date each month. Invoices will be sent to the Habersham County accounts payable department at the start of each month.

The City Council designates the Fire Chief and City Manager as the City's representative to participate in the study process and provide input on behalf of the City.

#### 4. Community Engagement:

The City Council commits to ensuring community engagement throughout the study process to gather input and maintain transparency.

#### 5. No Obligation to Consolidate:

Participation in the study does not obligate the City of Clarkesville, in any way, to proceed with consolidation. Any decision regarding consolidation will require further evaluation and separate approval by the City Council.
