COMMISSION ACTION REQUESTED ON: February 17, 2025 (Second Reading)

PURPOSE:

To obtain approval from the Habersham County Board of Commissioners for Chapter 30, Article III, Fire Alarms.

BACKGROUND / HISTORY:

- a. Fire Alarms installations are becoming more commonplace in both residential and commercial buildings.
 - b. The systems are often monitored by a third-party agency and when the alarms are activated, calls are placed to the jurisdiction's 911 Center.
 - c. Fire and EMS units are then dispatched to the address of the alarm.
 - d. When working properly, these alarms can save lives and property, as well as, provide earlier mitigation of an incident.

FACTS AND ISSUES:

- a. There has been a significant increase in "Fire Alarms" over the past 3 years. From 138 alarms in 2022 to 209 in 2024.
 - b. Of the alarms, in 2022 and 2023, 5 were to the same address, 3 or more times
 - c. In 2024, the number increased to 13 responses to the same address 3 or more times.
 - d. Assets are not available to answer additional calls due to the response to the "Alarm".
 - e. Unnecessary wear and tear on equipment and personnel.
 - f. This ordinance will provide oversight and direction for property owners in maintaining their alarm systems in working order.

AN AMENDMENT TO THE HABERSHAM COUNTY CODE OF ORDINANCES TO AMEND CHAPTER 30 ENTITLED "FIRE PREVENTION AND PROTECTION" TO PROVIDE FOR A NEW ARTICLE III ENTITLED "FIRE ALARMS"; TO PROVIDE FOR ADMINISTRATION AND ENFORCEMENT, TO PROVIDE FOR DEFINITIONS; TO PROVIDE FOR OPERATION AND MAINTENANCE; TO PROVIDE FOR TRANSMISSION; TO PROVIDE FOR PROHIBITION OF INTENTIONAL FALSE ALARMS; TO PROVIDE FOR AUTOMATIC DIALING DEVICE RESTRICTIONS; TO PROVIDE FOR REQUIRED EQUIPMENT; TO PROVIDE FOR NONDISCLOSURE OF INFORMATION; TO PROHIBIT EXCESSIVE ALARM RESPONSES; TO PROVIDE FOR INSPECTIONS OF ALARM SYSTEMS; TO PROVIDE FOR NONCOMPLIANCE WITH INSPECTIONS; TO PROVIDE FOR SUBSEQUENT VIOLATIONS; TO PROVIDE FOR APPEALS; TO PROVIDE FOR IMMUNITY; TO PROVIDE FOR PENALTIES; TO REPEAL CONFLICTING ORDINANCES; TO PROVIDE FOR AN EFFECTIVE DATE AND FOR OTHER PURPOSES

WHEREAS, the duly elected governing authority of Habersham County Georgia is authorized under Article IX, Section II, Paragraph III of the Constitution of the State of Georgia to adopt reasonable ordinances to protect the public health, safety, and welfare of the citizens of Habersham County, Georgia; and

WHEREAS, fire alarms and fire alarm systems are necessary components of a functional fire prevention and protection program; and

WHEREAS, the Board of Commissioners desires to enact regulations, restrictions and penalties regarding such fire alarms and fire alarm systems including penalties for intentional false alarms and excessive alarm responses which thereby endanger the citizens of Habersham County;

NOW, THEREFORE, THE BOARD OF COMMISSIONERS OF HABERSHAM COUNTY HEREBY ORDAINS AND IT IS HEREBY ORDAINED AND ESTABLISHED BY THE AUTHORITY OF THE SAME as follows:

Chapter 30 of the Habersham County Code of Ordinances is hereby amended by adding a new Article III as follows.

ARTICLE III. – FIRE ALARMS

Secs. 30-25 – 30-30 – Reserved.

Sec. 30-31. - Administration and enforcement.

Habersham County Emergency Services shall be responsible for the administration and enforcement of this chapter.

Sec. 30-32. - Definitions.

For the purposes of this chapter, the following words and phrases shall have the meanings given:

Alarm company means any corporation, partnership, business or individual, licensed by the State of Georgia, engaged in the business or the installation, maintenance, alteration, servicing, or monitoring of an alarm system or which responds to such alarm systems.

Alarm response means any response to a premise by Habersham County Emergency Services because of an alarm signal received by Habersham County 9-1-1 or Habersham County Emergency Services.

Alarm signals mean the activation of an alarm system resulting in a request for an alarm response regardless of cause.

An alarm system means any assembly of equipment, mechanical or electrical, designed to signal an occurrence of fire, smoke, heat, or water application, or any other circumstances requiring urgent attention and to which Habersham County Emergency Services personnel are expected to respond.

Required system means a fire alarm system installed in an occupancy in which the current Fire Code of Habersham County requires said system be installed.

Nonrequired system means a fire alarm system installed in an occupancy in which the Fire Code of Habersham County does not require said system to be installed.

Combination system means an alarm system that includes both security protection and fire detection in the same system.

Alarm user means any person, firm, partnership, association, corporation, company or organization of any kind who or which purchases, leases, contracts for, or otherwise obtains an alarm system, or the servicing, maintenance or monitoring of an alarm system from an alarm company.

Automatic dialing device means a device which is interconnected to a telephone line and is programmed to dial a predetermined telephone number, and which automatically transmits by recorded voice message or signal the existence of a hazard requiring urgent attention and to which firefighters are expected to respond.

County means Habersham County, Georgia.

False alarms mean any signal of fire, heat, smoke or water application, or any other circumstance when there exists no actual or threatened emergency to which Habersham County Emergency Services personnel are expected to respond.

Fire alarm code means the currently enforced fire code for Habersham County. It is the responsibility of all alarm companies to be aware of the currently enforced code for Habersham County.

Governing authority means the Board of Commissioners of Habersham County, Georgia.

Habersham County Emergency Services means Habersham County Emergency Services or other government department as requested by Habersham County Emergency Services to render aid.

Person means any individual, group of persons, firm, partnership, association of any kind, company or corporation.

Protected premises means the premises upon which an alarm system has been placed for the purpose of detecting a hazard.

Sec. 30-33. - Operation and maintenance; transmission.

Alarm companies, alarm users or individuals transmitting alarm signals are responsible for keeping their alarm system in good working order and repair and the county shall have no obligation with respect thereto.

Sec. 30-34. - Intentional false alarms are prohibited.

It shall be unlawful for any person to knowingly activate an alarm system to summon Habersham County Emergency Services when there is no actual or threatening need for the immediate assistance of Habersham County Emergency Services.

Sec. 30-35. - Automatic dialing device restrictions.

It shall be unlawful for any person to install, operate or maintain any automated dialing device which is programmed to transmit a prerecorded message or code signal directly to Habersham County 9-1-1 or Habersham County Emergency Services as an alarm signal.

Sec. 30-36. - Required equipment.

- a) An alarm system operated within the jurisdiction of the governing authority should be equipped in such a manner to prevent false alarms due to interruptions in electrical power.
- b) After the effective date of this chapter, all combination systems installed as a nonrequired system in single-family residences shall not include an outside sounder that is audible beyond the confines of the premise.
- c) After the effective date of this chapter, it shall be the responsibility of the alarm company on all new alarm systems to post on the alarm panel the name and 24-hour contact information for the company responsible for servicing the alarm system as well as the contact information for the alarm company responsible for monitoring the alarm system if it is different from the servicing company. Further it shall be the responsibility of the alarm company to update this information on existing systems at any time the alarm system is serviced.

Sec. 30-37. - Information not to be disclosed.

Any information supplied to Habersham County 9-1-1 or Habersham County Emergency Services pursuant to this chapter shall be held in confidence by all employees or representatives of the governing authority with access to such information. Because all alarm registration information is considered sensitive public safety information, the same shall not be available to the public, unless otherwise required by law.

Sec. 30-38. - Excessive alarm responses are prohibited.

- a) It shall be unlawful for any alarm user in the jurisdiction of the governing authority to allow an excessive number of alarm responses to occur at a protected premise for which the alarm user is responsible.
- b) Alarm responses to a protected premise more than three times in any consecutive four-month period or five times in any consecutive 12-month period are deemed to be an excessive number and shall be a violation of this chapter.
- c) If an alarm user shows to the satisfaction of Habersham County Emergency Services representative that the false alarm was not the result of the negligence or improper maintenance by the alarm user, the administrative fee sanction as specified in Sec. 30-40 of this chapter may be waived.
- d) Habersham County Emergency Services personnel assigned to incidents which are determined to be an alarm response shall, whenever possible, leave written notice for the alarm user which provides the following information.
 - 1) Date and time of alarm response.
 - 2) Habersham County Emergency Services contact information including phone number.
 - 3) A brief synopsis of the fire alarm ordinance.

Sec. 30-39. - Inspection of alarm systems.

An alarm user with an alarm system in violation of Sec. 30-38 of this chapter shall cause their alarm system to be inspected by an alarm company licensed to conduct business as an alarm company. The inspection shall entail a complete examination of the alarm system including, but not limited to, satisfactory design and installation of the equipment, proper functioning of the equipment and user education in the operation of the equipment. The alarm company shall record the details of the inspection and make such a record available to the alarm user. Notification of the requirements of this section for an inspection shall be made by Habersham County Emergency Services in writing, within 30 days of the violation, to the registered alarm user. The completed inspection report from an alarm company shall be returned to Habersham County Emergency Services by the alarm user within 30 days of the initial notification of the violation by Habersham County Emergency Services.

Sec. 30-40. - Noncompliance with inspection.

If Habersham County Emergency Services does not receive a written completed inspection report within thirty days of the notification as provided in Sec. 30-39, an administrative service fee for noncompliance with the inspection report request as specified in the fire alarm fee schedule adopted by the governing authority as part of its annual fee schedule adoption in accordance with Chapter 28 hereof shall be assessed against the alarm user.

Sec. 30-41. - Subsequent violations.

If within 12 months of the notification provided in Sec. 30-39 of this chapter, there are more than two alarm responses to a protected premise, excessive alarm response fees shall be assessed against the user for all subsequent alarm responses as specified in the fire alarm fee schedule adopted by the governing authority as part of its annual fee schedule adoption in accordance with Chapter 28 hereof.

Sec. 30-42. - Appeals.

- a) The Habersham County, Georgia Board of Commissioners shall hear the appeal upon request of any alarm company or alarm user adversely affected by any decision of the Habersham County Emergency Services.
- b) Appeals to the Habersham County Board of Commissioners shall be filed in writing with the Clerk of the Habersham County Board of Commissioners within three days from the date of service of written notice of a decision adversely affecting an alarm user of an alarm company.
- c) Failure to file an appeal within such three-day period shall constitute a waiver of the right to such an appeal.
- d) The decision of the Habersham County Board of Commissioners shall be final.

Sec. 30-43. - Immunity.

Nothing in this chapter is intended to, nor will it, create a contract, duty or obligation, either expressed or implied, of response. All liability and consequential damage resulting from the failure to respond to a notification is hereby disclaimed and governmental immunity as provided by law is retained. By notification of an alarm system, the alarm user acknowledges that the Habersham County response may be influenced by factors such as: the availability of emergency units, priority of calls, weather conditions, traffic conditions, staffing levels and prior response history.

Sec. 30-44. - Penalties.

Any person, firm, corporation, association or partnership violating any provision of this chapter as the same exists or as it may hereinafter be amended, or shall fail to do anything required by this chapter as the same exists or as it may hereafter be amended, shall be guilty of a misdemeanor, amenable to the process of the magistrate or state court of Habersham County, and upon conviction, shall be subject to a fine not to exceed \$1,000.00 for each violation in the discretion of the court. Each day such violation is committed or permitted to continue shall constitute a separate offense and shall be punishable as such hereunder.

Sec. 30-45. -- 30-50. — Reserved.

Conflicting Laws and Regulations

All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

Severability

If any of the provisions of this ordinance or the application thereof to any person or circumstances are held invalid, such invalidity shall not affect other provisions or applications of the ordinance which can be given effect without the invalid provision or application, and to this end, the provisions of this ordinance are declared to be severable.

Effective Date.

This ordinance shall become effective upon its adoption.

Commissioners,

I need to bring a matter to your attention to determine how to proceed in resolving it. We have been dispatched to Apple Mountain Resort more than 60 times this year for a fire alarm activation. None of the instances involved a fire, but more often than not, the activation was due to someone cooking on the stove or in the oven. On December 6th, I contacted the manager of the resort to request the situation between the resort and the alarm company, CINTAS, be resolved. She advised it was a new system, and CINTAS had found nothing wrong with any components of the system.

After the initial contact, a follow-up email was sent as the alarm activations had not decreased in the least. Ms. Purnell (Holiday Inn Resort Manager) advised a technician was to be onsite that day to check out the system. She advised she would update me with any additional information. The last communication was on December 16th and there has been no update and the alarm activations continue.

Donnie Hunt suggested bringing this before you to determine what direction, the Board wants to take with this matter.

A “Fire Alarm Ordinance” was researched and found that many counties have this in place to mitigate these situations. Hall, Forsyth, Gwinnett, Dawson, Cherokee and Fayette all have these ordinances in place. The triggers and penalties differ from county to county and would need to be defined by the commission.

Dawson County

- (1) For the third nuisance fire alarm within a calendar year, a fine of \$100.00 shall be imposed upon each responsible party;
- (2) For the fourth nuisance fire alarm within a calendar year, a fine of \$250.00 shall be imposed upon each responsible party;
- (3) For the fifth and each subsequent nuisance fire alarm within a calendar year, a fine of \$1,000.00 shall be imposed upon each responsible party.

Hall County

B. Alarm responses to a protected premise in excess of three times in any consecutive four-month period or five times in any consecutive 12-month period are deemed to be an excessive number and shall be a violation of this chapter.

8.80.040. - Penalty.

Any person, firm, corporation, association or partnership violating any provision of this chapter as the same exists or as it may hereinafter be amended, or shall fail to do anything required by this

chapter as the same exists or as it may hereafter be amended, shall be guilty of a misdemeanor, amenable to the process of the Magistrate or State Court of Hall County, and upon conviction, shall be punished as provided in the Official Code of Hall County, Georgia section [1.50.020](#) for each violation in the discretion of the court.

Barrow County

(d) Service fees imposed.

(1) For each response to a false *alarm*, a report shall be made and forwarded to the marshal's office. The chief *fire* marshal or his/her designee shall take the following actions:

a. For the first false *alarm* from a premises within a six-month period, the marshal shall forward to the property owner or premises lessee a copy of the report, a copy of this chapter, and a statement that continued false *alarms* will lead to a service fee;

b. For the second false *alarm* from a premises within a 12-month period, the marshal shall suggest the *alarm* system to be inspected by a state licensed *alarm* low voltage contractor and to prescribe necessary corrective action (this will be done at the owner's expense);

c. For the third false *alarm* within a 12-month period, the property owner or lessee shall be charged a fee of \$50.00; and

d. For the fourth false *alarm* and all succeeding *alarms* within a 12-month period, the property owner or lessee shall be charged a fee up to \$100.00 per *alarm* and each additional *alarm* thereafter.

The 911 Center provided the “Fire Alarm” county-wide for the past 3 years. It goes without saying, that things happen... The concern is if the activations continue to occur without any active corrective measures being taken by the property owner. The number of alarms occurring more than 3 times from the same location; 5 times in 2022 and 2023. In 2024, 11 times with 9 of those locations having more than 5 activations.

Accompanying this is the report from the 911 center for “Fire Alarms” for the last 3 years.

Below is a listing from the 911 Center for each time a call was generated and fire units responded to Apple Mountain Resort in 2024.

It is my thought, that a Fire Alarm Ordinance should be created, similar to one of the counties listed above. From that point the criteria would then be established by the BOC as to what constitutes a nuisance alarm and at what point should penalties be imposed.

Please let me know how you would like to proceed.
