#### History of the Landfill


- Habersham County has managed waste disposal through various methods over the years.
- This 1953 photograph depicts an open garbage dump in Clarkesville indicating the use of open dumps during that time-period.




### History Continued...

- ► The Pea Ridge Landfill closed October 8, 1993, making way for the new Habersham County Landfill located in Mt. Airy to begin service to Habersham County's citizens.
- The Habersham County Landfill began operating in 1993. The lined landfill is environmentally sound, cost-effective, and complies with all federal, state, and local ordinances.
- ► The landfill is currently operating on a budget of \$2.78 million for the FY25 fiscal year and operates as an enterprise fund which does not directly include any general tax revenues.

#### Life of the Landfill

- On a yearly average, based on the date from May 2023 May 2024 the Scale House Attendant will average processing as many as 103 customers daily and will receive approximately 129 tons MSW daily.
- ► This results in **32,089** customers and **40,033.58** tons of MSW/Recycling coming into the Landfill on a yearly average.
- ► As of July 26, 2024, we are looking at approximately **19.0** years of life left in the Landfill.

#### Remaining MSW Capacity Report August 23, 2023

- ► The Remaining Capacity Report for August 28, 2023, estimated the remaining capacity of the landfill was 16.7 years.
- ► The estimated date of completion is May 2040.
- This is the official certified report from the engineering firm of Hodges, Harbin, Newberry & Tribble (HHNT).

#### Landfill Operations

- The facility serves as the primary site for waste disposal, including household garbage and recyclables. As of February 29, 2024, the landfill ceased accepting construction and demolition (C&D) debris due to capacity concerns.
- ➤ To support recycling efforts at the Landfill and to lessen the traffic in the working face, a convenience center for residents with 6 bags or less of household garbage and receptacles for recyclables is provided.
- Overall, Habersham County's approach to waste management has evolved from open dumps to a more structured landfill operation and recycling program reflecting a commitment to public health and environmental stewardship.








### Habersham Recycling History

Recycling in Habersham County started many years ago. In 1950, the Clarkesville PTA started a drive to collect and sell waste paper with the revenue going to the PTA to use for worthy projects.



### Habersham Recycling Tonnages

Data from May 2023 to May of 2024 Habersham County Recycling received the 446.61 tons (893,220 lbs.) of recyclable materials which were diverted from the Landfill.

### Clarkesville Recycling Center: Then and Now

- ► The Clarkesville Recycling Center, located at 4142 Toccoa Highway in Clarkesville, Georgia, is a key facility in Habersham County's waste management strategy. In early 2024, the county expanded the center's operating days to address concerns about the landfill's capacity.
- Previously open only three days a week, the center extended its hours to Monday through Saturday, from 8:00 a.m. to 4:30 p.m., to encourage and provide the opportunity for more residents to recycle and thereby reduce the strain on the landfill.
- This initiative was part of a broader effort by the County to promote recycling and extend the landfill's lifespan. By increasing accessibility to recycling facilities, this will divert more materials from the landfill, contributing to environmental sustainability and cost savings for the community.

### Clarkesville Recycling Center Up-Grades

► NEW ATTENDANT'S BUILDING

Up-grades to Clarkesville include a New Attendant Building which provides a safe and sanitary work area for the Attendants. The portable restroom was replaced with an operational restroom complete with hot running water so that Attendants will now be able to wash their hands after working the recycling collection bins and cleaning the grounds.



#### Clarkesville Recycling Center: 2024 Up-Grades

- Self-Contained Compactors
- Installation of 2 self-contained compactors has eliminated the use of metal steps which posed a safety risk especially for the elderly and handicapped citizens who visit the Recycling Center. These cans set on cement pads and allow citizens to walk up to the cans to recycle cardboard and paper. Once these cans reach capacity, our Roll Off driver transports the cans to Hall County Recycling.



#### Clarkesville Recycling Center: Clothing, Textiles, & Electronics

- Habersham County partnered with ATS (Americas Thrift Store) and CHOA (Childrens Healthcare of Atlanta) in providing collection sites and bins for collecting clothing/textiles for recycling.
- This effort not only provides revenue to Habersham County, but a percentage of sales donation is also made to CHOA on behalf of Habersham County.
- ▶ Electronics Recycling collection bin will be coming Summer 2025.



## Cornelia Recycling Center: Up-Grades

- ▶ The Cornelia Recycling Center, located at 507 Nicolon Dr. Cornelia, Georgia, is another key facility in Habersham County's waste management strategy. In early 2024, the county expanded the center's operating days to address concerns about the landfill's capacity.
- ▶ Previously open only three days a week, the center extended its hours to Monday through Saturday, from 8:00 a.m. to 4:30 p.m., to encourage and provide the opportunity for more residents to recycle and thereby reduce the strain on the landfill.
- ► This initiative was part of a broader effort by the County to promote recycling and extend the landfill's lifespan. By increasing accessibility to recycling facilities, this will divert more materials from the landfill, contributing to environmental sustainability and cost savings for the community.

- Self Contained Compactors
- The installation of 2 self-contained compactors will eliminate the use of metal steps which pose a safety risk especially for the elderly and handicapped citizens who visit the Recycling Center. Once these cans reach capacity, our Roll Off driver transports the cans to Hall County Recycling.

- Habersham County partnered with ATS (Americas Thrift Store) and CHOA (Childrens Healthcare of Atlanta) in providing collection sites and bins for collecting clothing/textiles for recycling.
- This effort not only provides revenue to Habersham County, but a percentage of sales donation is also made to CHOA on behalf of Habersham County.
- ▶ Electronics Recycling collection bin will be coming Summer 2025.

## Recycling Fees May 2023 – May 2024

- ▶ POTENTIAL REVENUE FEES\* = PROFIT
- **▶** \$34,470.00−\$37,200.00 = -\$2,730.00
- These numbers are exactly why we have taken the initiative to revamp our recycling program.
- We have purchased a roll off truck which now allows us to be able to haul the paper, cardboard, glass, plastics, and aluminum with 0 hauling/rental fees paid to outside vendors.
- We have purchased 4 SCC to place at Clarkesville and Cornelia recycling centers. Clarkesville's SCC cans are now installed and operational. Cornelia's SCC cans will be operational by early March.

## Recycling Fees June 2024 – January 2025

- REVENUE FEES = PROFIT
- ► \$24,524.00 \$12,500.00 = \$12,024.00
- ▶ The hauling fees of \$12,500.00 resulted from paper trailer rental fees and hauling fees from Paper Recovery of Georgia.
- Paper recovery notified us that they would no longer service Habersham County for paper recycling in July 2024. However, they did agree that they would hold off on picking up their paper trailers until the trailers reached full capacity. PPG picked up their last rental trailer from Cornelia in January 2025.
- ► Habersham County now hauls **ALL** of the recycling collected at the recycling sites.

### TIRES!! TIRES!!...What to do with the tires?? TIRE AMNESTY

- STAR GRANT Scrap Tire Abatement Reimbursement
   Georgia Environmental Protection Division
- Habersham County Solid Waste is applying for the STAR Grant this year.

This grant assist local governments with the safe removal and recycling of scrap tires. The grant covers the costs of removing, transporting and processing scrap tires. This grant will afford Habersham County the ability to allow citizens to bring scrap tires to the Tire Amnesty site free of charge for select dates. We would like to hold Tire Amnesty Day for 2 consecutive days this year, We are setting our goal to hold this in April.



# HABERSHAM COUNTY RECYCLING FUTURE GOALS

- Baled Commodities Holding Facility
  - This will allow for baling and holding plastics and aluminum cans to sale on the commodities market to the highest bidder. Thus, generating an increase in revenue.
- Establish a new Recycling Center
  - This recycling center would, by design, better serve the citizens of Habersham County in their recycling efforts by offering a paved and covered drive thru area where citizens could drive up to the strategically placed recycling bins without concern of weather.
- Apply for grants that will aid in the recycling endeavors.

#### Conclusion and Call To Action

- Recycling plays a crucial role in extending the life of our landfill, reducing waste, and creating a more sustainable future for Habersham County.
- By expanding our recycling initiatives, strengthening partnerships, and increasing community involvement, we can significantly reduce the volume of waste entering the landfill and extend its usability.
- With the current projections showing that the landfill will reach full capacity by July of 2043, it is imperative that we take action now to develop future plans for the landfill whether that will be purchasing new land to develop a new landfill or building a transfer station for the citizens to be able to dispose of their MSW properly. Either of these projects is extremely time consuming and heavily regulated by the EPD.
- I urge you, Habersham County Commissioners, to continue supporting and improving our recycling efforts. Investing in sustainable waste management practices will ensure that we have long-term solutions for tomorrow. Let's work together to make the landfill and recycling a priority, protect our environment, and secure a cleaner, more efficient waste management system for future generations.
